

Sweepstakes Terms & Conditions

Franklin Mint Federal Credit Union (FMFCU)
Debit Card Sweepstakes Official Rules

NO PURCHASE OR TRANSACTION REQUIRED TO ENTER. This sweepstakes is open to individuals age 18 and older. FMFCU members must also be in good standing as of May 31, 2024 to be eligible. Employees of FMFCU and its subsidiaries, along with immediate family members, are ineligible. Sweepstakes begins on June 3, 2024 at midnight Eastern Daylight Time and runs through June 30, 2024 at 11:59 PM Eastern Daylight Time. Void where prohibited.

HOW TO ENTER. Any FMFCU member who performs a debit card transaction and chooses CREDIT (non-pin) is automatically entered in the sweepstakes. All debit card online purchases are also eligible transactions. Members will receive one (1) entry for every eligible transaction made between June 3, 2024 and June 30, 2024. All other individuals 18 and older may enter sweepstakes by sending full name, complete mailing address, telephone number or email address to:

PRIZES, ODDS, AND WINNER SELECTION. Three (3) winners will be randomly selected from pool of entries. First selected winner receives \$2,000. Additional two selected winners receive \$1,000. Winners selected by July 19, 2024 and \$2,000 and \$1,000 awarded by check or direct deposit to an FMFCU checking or savings account. All decisions are final. Odds of winning depends on number of entries. Winners notified via telephone or email by July 24, 2024. No substitution or transfer of prize permitted by winners. All prizes will be awarded.

CONDITIONS OF PARTICIPATION. Participation in the sweepstakes constitutes an entrant's full and unconditional agreement to and acceptance of these Terms and Conditions and decisions of FMFCU, which are final and binding in all matters relating to this sweepstakes.
